Requirements:	 All owners must be 65 years of age or older by December 31, 2014. Property owned by married couples, OR siblings, only one must be 65 years of age or older. One of the applicants must be the owner and occupant of a one, two, three-family residence, farm home, condominium or Co-op. (The Star Enhanced Exemption is not available for seasonal residences.) Combined income of all owners and spouse(s) cannot exceed the Federal Adjusted Gross income of \$81,900 as shown on Federal or State Income Tax Return Form 1040 (See the definition of income for STAR purposes on the back of this form). If your GROSS income is under \$37,399.99 you may qualify for a Senior Citizen Low Income Exemption (RP467).

GENERAL INSTRUCTIONS

The New York State School Tax Relief (STAR) Program provides an exemption from school taxes for owner occupied, primary residences. Senior citizens with combined 2012 incomes that do not exceed \$81,900 may qualify the "Star Enhanced" Exemption. Senior citizens who would like to continue receiving Enhanced STAR in future years without having to reapply and submit copies of their NYS Tax Returns to their assessor every year are invited to sign up for the STAR Income Verification Program. Please see form RP-425-IVP for more information.

Seniors who do not choose to enroll in the Income Verification Program must reapply each year to keep the Enhanced STAR Exemption in effect. If you are receiving the "Basic" Exemption, you do not need to reapply in subsequent years, but you must notify the assessor if your primary residence or ownership status changes.

To apply for either the Basic or Enhanced STAR Exemption, you must file application form RP-425 (STAR) or RP-425E (Star Enhanced) with your assessor of your city or town on or before the applicable "taxable status date." In towns, taxable status date is generally March 1st. For further information, please contact your local assessor.

<u>Application Instructions:</u> Print the name and mailing address of each person who both **owns and primarily resides** in the property. (If the title to the property is in a TRUST, the trust beneficiaries are deemed to be the owners for STAR purposes.) There is no single factor which determines whether the property is your primary residence, but factors such as voting and automobile registrations, and the length of time you occupy the property each year may be relevant. The assessor may ask you to provide proof of residency and ownership. For the Enhanced STAR Exemption, proof of age may also be required.

The parcel identification number may be obtained from either the assessment roll or your tax bill.
